Terms & Conditions of Sale

Resale Permit/Business License

Wholesale accounts are expected to have proper business permits and are required to fill out a resale card with permit number or equivalent for Scrapper's Guide to retain on file. If your state does not require a Resale Permit, please submit a copy of your business license or fictitious name statement. Retailer is responsible for all duties, taxes, or other government charges imposed by any federal, state, or local authority upon the goods sold in addition to their price.

Minimum Orders

Opening orders must be at least \$100. Reorders must be at least \$50. Reorders under the minimum are subject to a \$15 service charge. There are no quantity minimums.

Payment Terms

We recommend prepayment on first orders for faster processing. MasterCard or VISA transactions require pre-authorization before merchandise is shipped. Scrapper's Guide reserves the right to require prepayment only. To apply for Net 30 day billing, please fill out our Credit Application and allow approximately 3 weeks for processing. The Credit Application is available for download from the retailers link on the Scrapper's Guide home page. Customers in Canada may apply for Net 30 terms. Scrapper's Guide may elect to extend credit or to ship C.O.D. Acceptance by Scrapper's Guide of less than full payment shall not waive any of Scrapper's Guide's rights.

Past Due

Reorders will not be shipped while an account has a past due balance. Scrapper's Guide reserves the right to revoke Net 30 status at any time. Past due accounts are subject to a service charge of 1 1/2% per month (18% per annum).

Freight

All goods are shipped at Buyer's risk with shipping and handling charges FOB Portland, OR. Scrapper's Guide ships ground whenever possible unless you request otherwise and provide complete carrier information.

Delivery

We make every effort to ship orders that are correct and complete. Scrapper's Guide assumes no responsibility or liability for any loss or damage caused by delay or inability to deliver as a result of factors beyond Scrapper's Guide's control.

Expedited Orders

To ship an order the same day as placed, the order must be received before noon PST. A \$25 Expediting Fee will be charged for exceptions.

Cancelled Items

Items out of stock at the time your order is shipped will be cancelled. Please call customer service to reorder these cancelled items.

Returns

All returns must be made within thirty (30) days. Scrapper's Guide's Customer Service Department must issue an authorization number and shipping instructions prior to the return of goods from a customer. Returns without authorization numbers will be refused. Goods which are dated, special order, or custom packaged and labeled are not returnable. Returns must be in saleable condition.

Should you choose to return items within thirty (30) days, you must call for authorization, prepay transportation charges, and pay a 15% restocking fee.

Discontinued product is not acceptable for return. Please check with Customer Service for our most up-to-date product listing. Shortages and Damages

Shortages must be reported to the Scrapper's Guide Customer Service Department within ten (10) days of delivery.

Notification of damaged or defective merchandise must be made to the Scrapper's Guide Customer Service Department within thirty (30) days of receipt of order.

Defective product or products sent in error will be corrected, replaced, or credited.

International Accounts

The following conditions supersede any others previously listed.

1. All monies must be paid in advance by:
 - a. MasterCard or VISA
 - b. International certified Money Order in U.S. Dollars
2. Canadian customers may apply for Net 30 billing
3. We ship via US Postal Service Air Letter Post or Global Priority Mail unless Customer requests other carrier and provides complete carrier information.
4. All duties, Taxes, & Brokerage Fees are the responsibility of Customer.
